-  Do you own a single-unit home located in Nova Scotia? Row houses and most mobile homes qualify. Condos, multi-unit buildings and rentals do not.
-  Can you show that you own your home?
-  Do you live in your home year-round and don't plan to sell it in the near future?
-  Is your total family income within the levels shown in the chart?

- Your home has not already been upgraded through HomeWarming or the Low Income Homeowner Service.

**To apply:**

Step 1. Fill out, sign, and date this application.

Step 2. Attach the most recent tax Notice of Assessment for each resident 18 and over. This is the form you receive from the federal income tax office about a month after you file your income tax. If you have lost your Notice of Assessment, contact Canada Revenue Agency at 1-800-959-8281 to ask for a copy.

Step 3. Attach proof that you own your home. This can be your property tax assessment notice, property tax bill, or bill of sale. This must include your name and street address.
